RE: Highlights from the CoAEMSP Board Meeting – November 2-3, 2023

The Committee on Accreditation of Educational Programs for the EMS Professions (CoAEMSP) Board of Directors met in Oklahoma City, Okla., November 2-3, 2023. The highlights from the board meeting follow.

- 1. **Program Actions.** Reviewed 35 programs for initial accreditation, continuing accreditation, and progress reports.
- 2. **By the Numbers.** At the time of the meeting, there are 764 programs that hold a status. This is up 8 programs since the last quarterly meeting.

**641 CAAHEP accredited** Paramedic programs and **123 programs** that hold the **CoAEMSP Letter of Review (LoR);** the LoR is the precursor to CAAHEP accreditation.

3. Finance. Reviewed the preliminary first quarter-end financials for the fiscal year starting July 1, 2023.

In the next quarter a special workgroup comprised of board members and staff members will take a deep dive into the budget, identifying efficiencies, and projecting at least five years out.

- 4. **Data.** The strategic plan has spurred activity in the data and research arena. Presented the research paper written by the CoAEMSP and NREMT, *Medical Director Resource Deficiencies in Paramedic Programs.* NAEMSP selected this research poster as one of the top 3 presentations submitted for the annual meeting in 2024.
- 5. **Program Director Focus Group (PDFG).** Members of the PDFG provide expertise and insights to the CoAEMSP Board of Directors, especially relating to day-to-day operational aspects of CAAHEP accredited and CoAEMSP Letter of Review paramedic programs. Members of the group are volunteers and will serve for one year. The PDFG is not a governing body, does not set policy, and does not participate in accreditation decisions. Applications for the 2024-25 PDFG will open in the spring of 2024.

Highlights from the recent meeting include discussing the NREMT examination. Concern for student adaptation to new examination and how to educate/train students in preparation for the exam. Invited Dr. Paul Rosenberger from NREMT, to talk about the examination and Dr. Gina Scarboro, CAAHEP Executive Director, to talk about the relationship between the CoAEMSP, CAAHEP, and CHEA. Participants shared their concerns about recruiting and retaining faculty.

7. Voluntary Accreditation Services for AEMT Programs. To advance the recommendations of the 2019 National EMS Scope of Practice Model and the 2021 National EMS Education Standards, CAAHEP plans to launch a voluntary programmatic accreditation at the Advanced Emergency Medical Technician (AEMT) level by January 1, 2025, and the CoAEMSP will provide the accreditation services.

CoAEMSP conducted a national survey with program directors of AEMT programs. The survey represents the first real measure of interest in voluntary AEMT accreditation. The results indicate many AEMT Program Directors are both familiar with accreditation and its benefits and interested in seeking voluntary accreditation. - 8. **IDEA Working Group.** Met with the NREMT about collecting and reporting on data related to demographic makeup of EMS students in CAAHEP-accredited and CoAEMSP Letter of Review programs to improve recruitment, retention, and diversity among student populations.
- 9. **ACCREDITCON.** The evaluations were positive for the 2023 event and provided constructive considerations for future ACCREDITCONs. Registration is open for the 2024 event, which will be held May 29-June 2, in Oklahoma City. Site selection for the 2025-2029 is well underway.

This year we had four of the CoAEMSP sponsors and CAAHEP joining us, including AAP, NAEMSE, NAEMT, NREMT. In 2024, we have commitments from AAP, NAEMSE, NAEMT, NREMT, and CAAHEP.

- 10. **Policies and Interpretations for Programs.** Policy manual was reviewed and proposed edits as they pertain to providing accreditation services to AEMT programs and accreditation services to international programs. CoAEMSP gained approval from CAAHEP to offer accreditation services to international programs. The CoAEMSP Policy Manual with changes is available <a href="here">here</a>. - 11. **Quality Improvement & Site Visits.** The CoAEMSP is increasing its cadre of site visitors; therefore, has opened the site visitor application period. The next Site Visitor Workshop will be held at ACCREDITCON-2024. Other initiatives include: continuing with quarterly Conversations with Site Visitors; streamlining the documents and evidence requested for the site visit; developing a list of What If?, which are questions from reviewing the Site Visit Reports and writing the Site Visit Findings Letters; developing the Site Visitor Quick Reference Guide; and editing the Site Visitor Manual. Finally, the committee reviewed the evaluations completed by site visitors, program directors, and deans following the site visit.
